ON THE

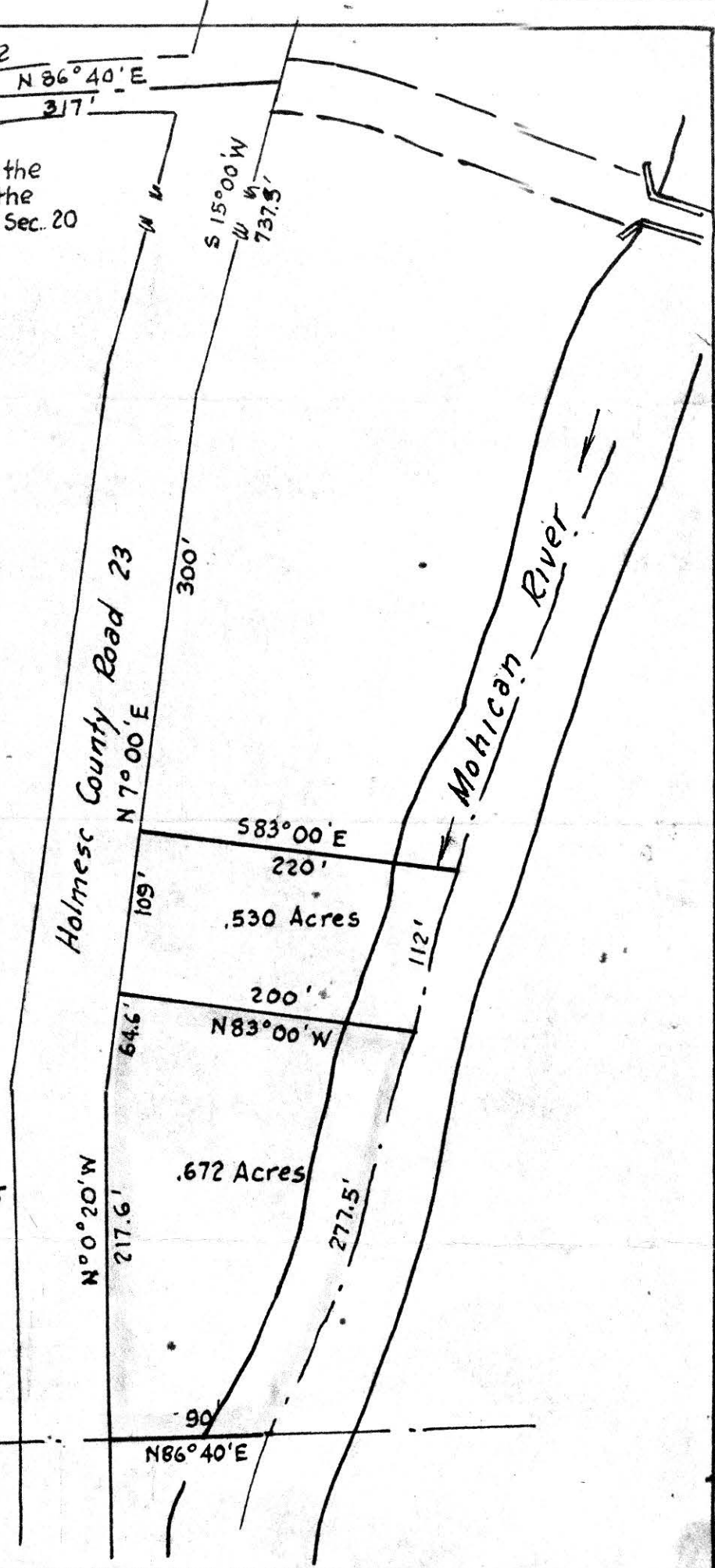

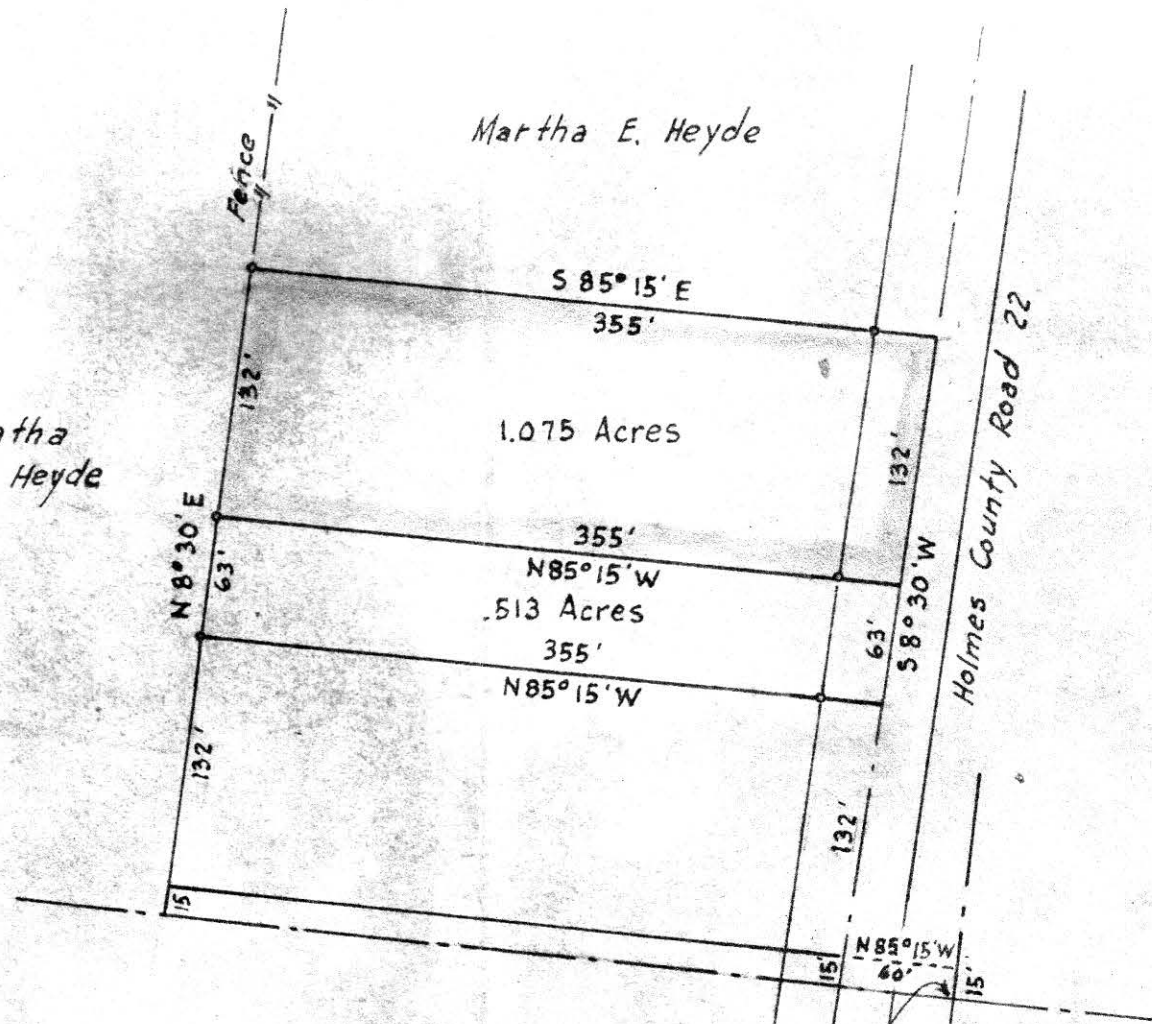

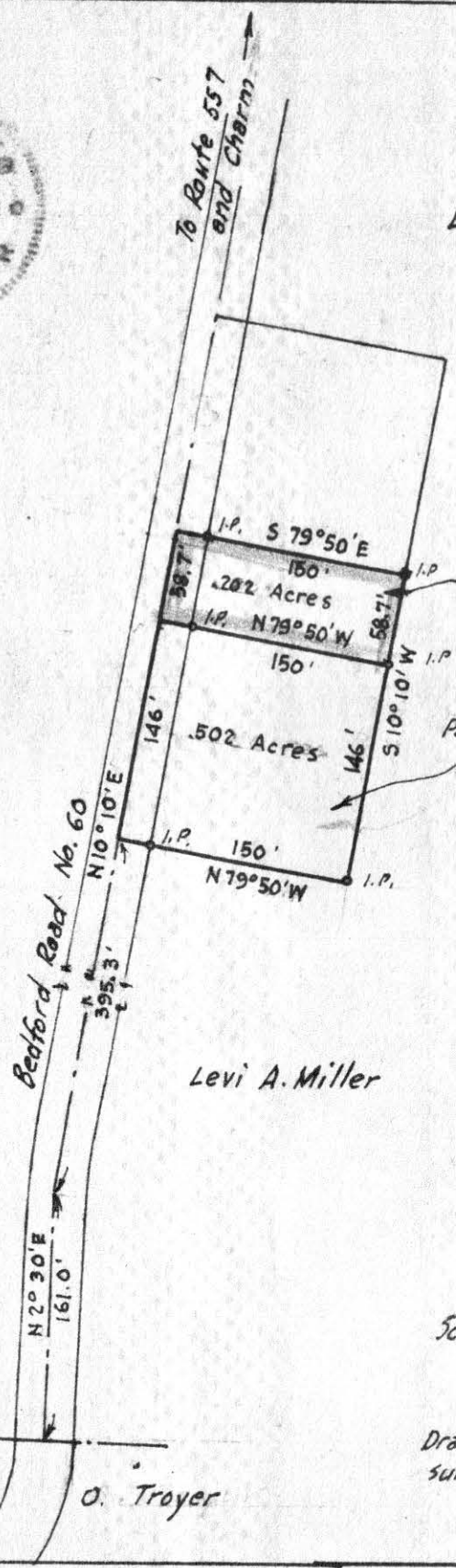
