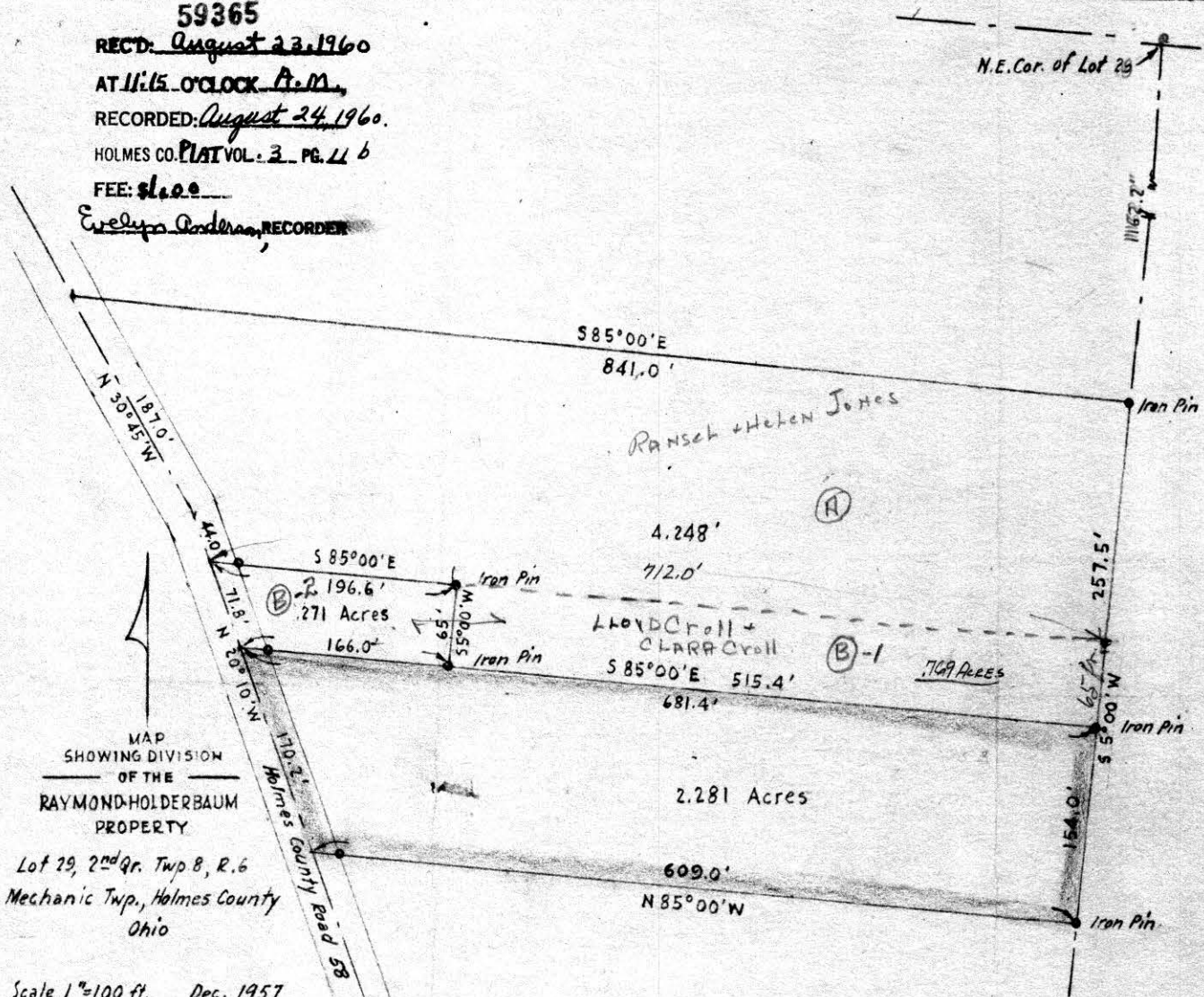

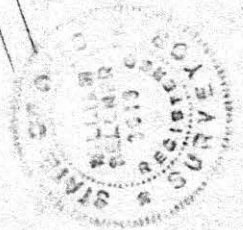

IN

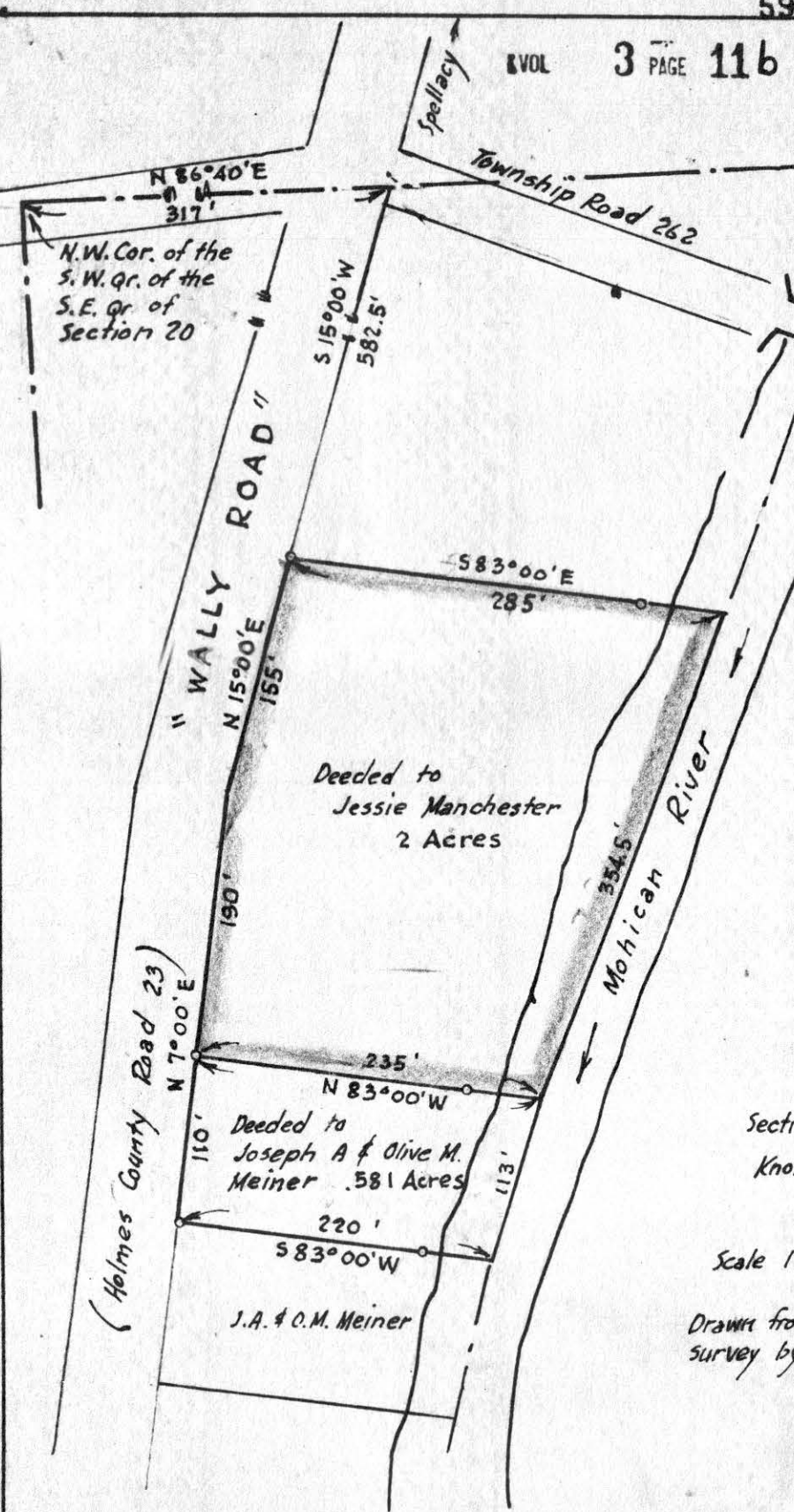
