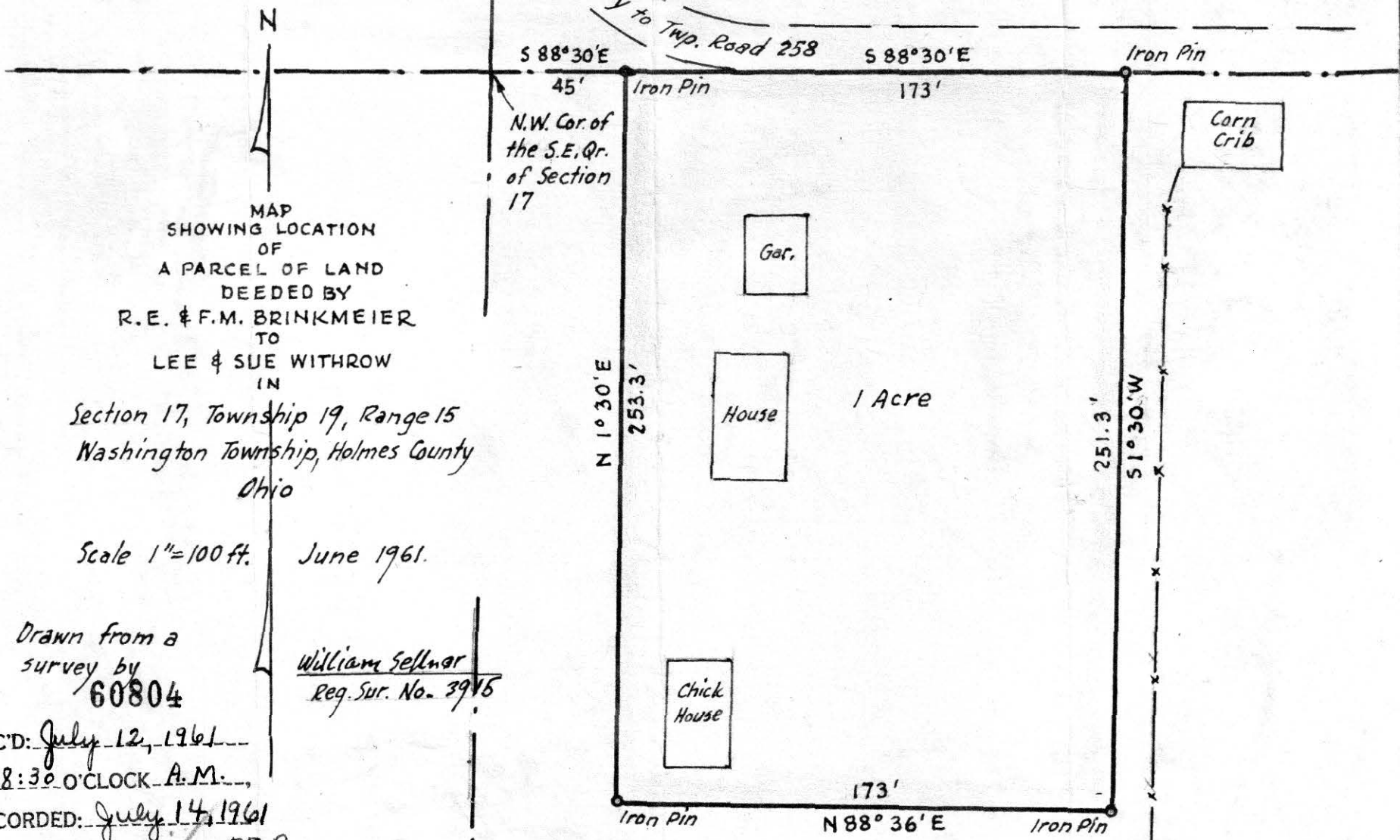
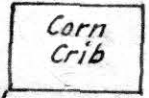
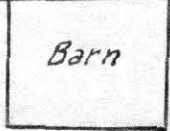
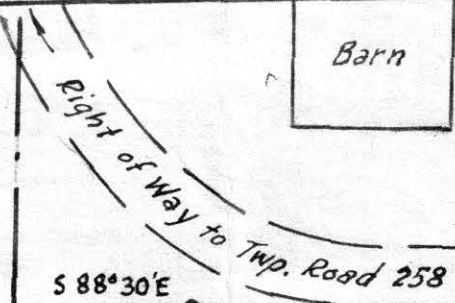
MAP

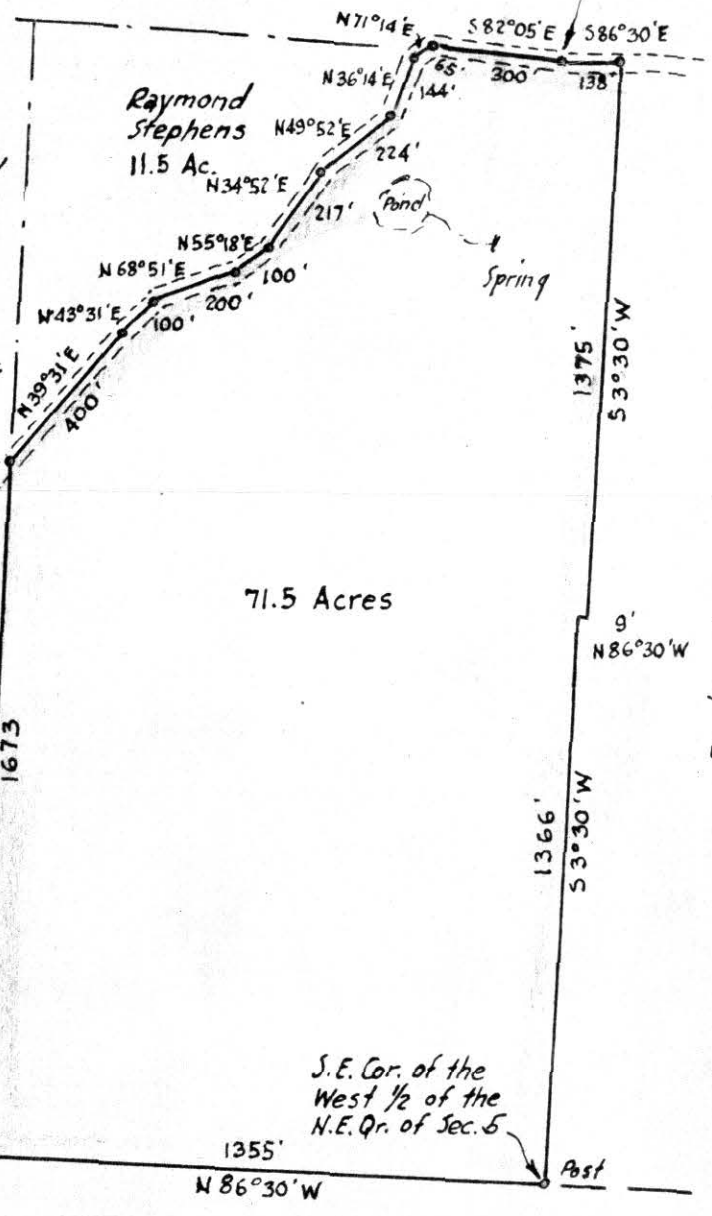

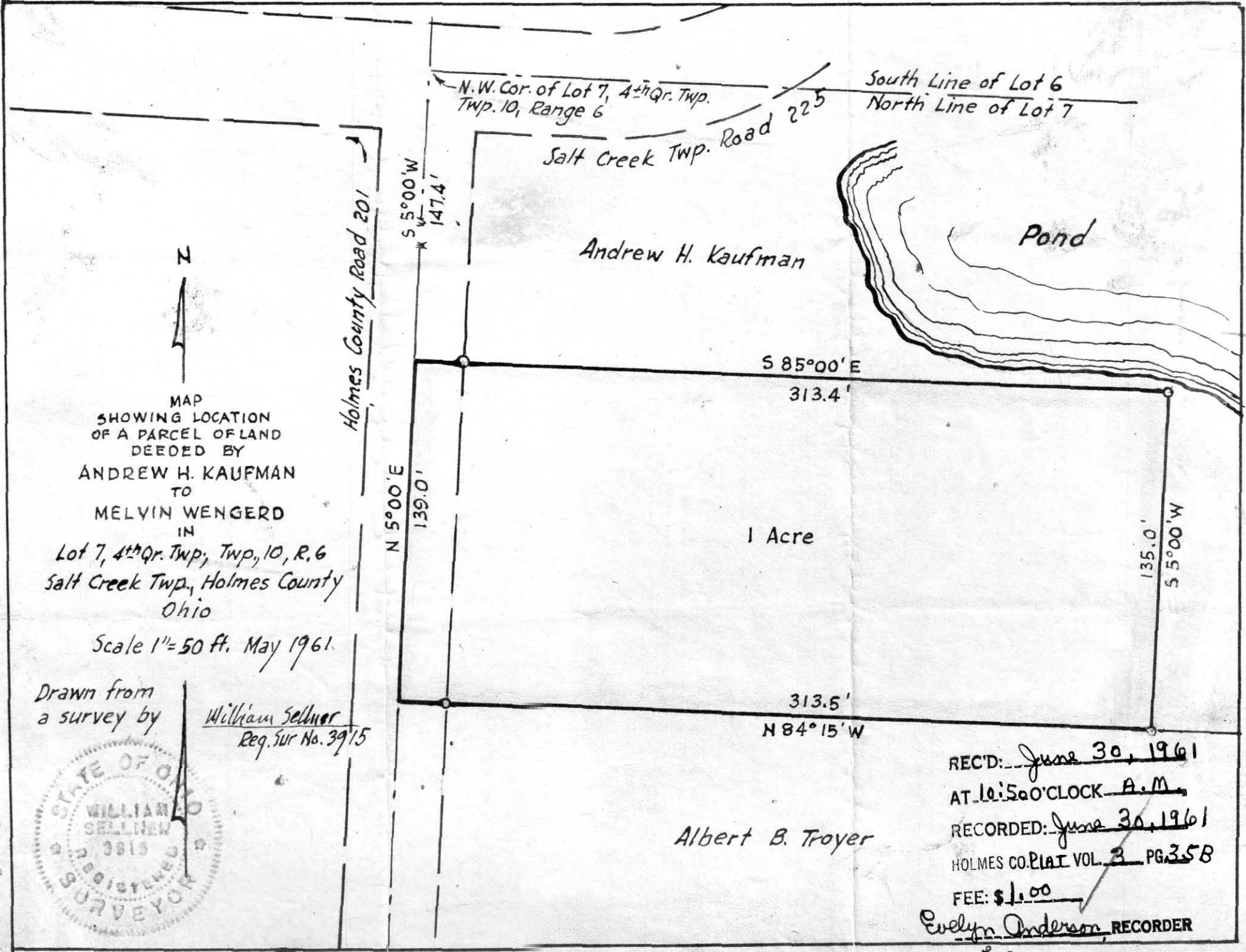
