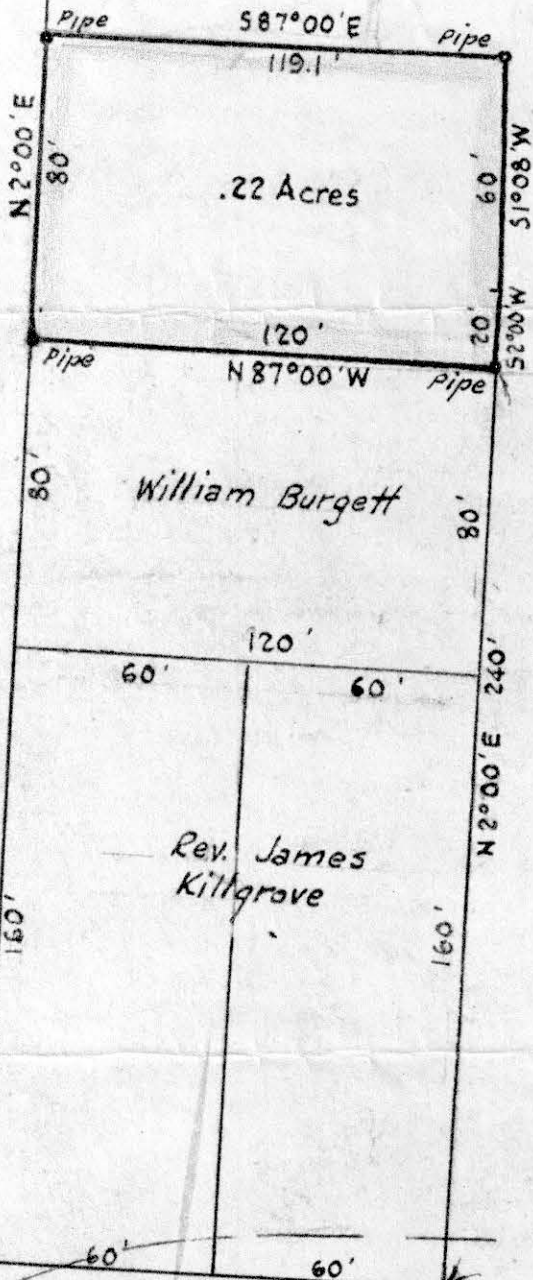

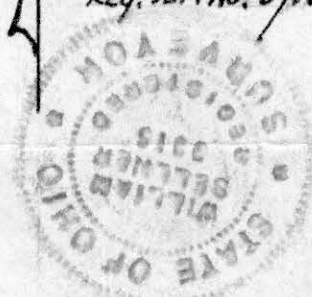

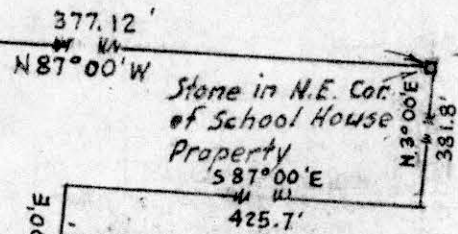


MAP

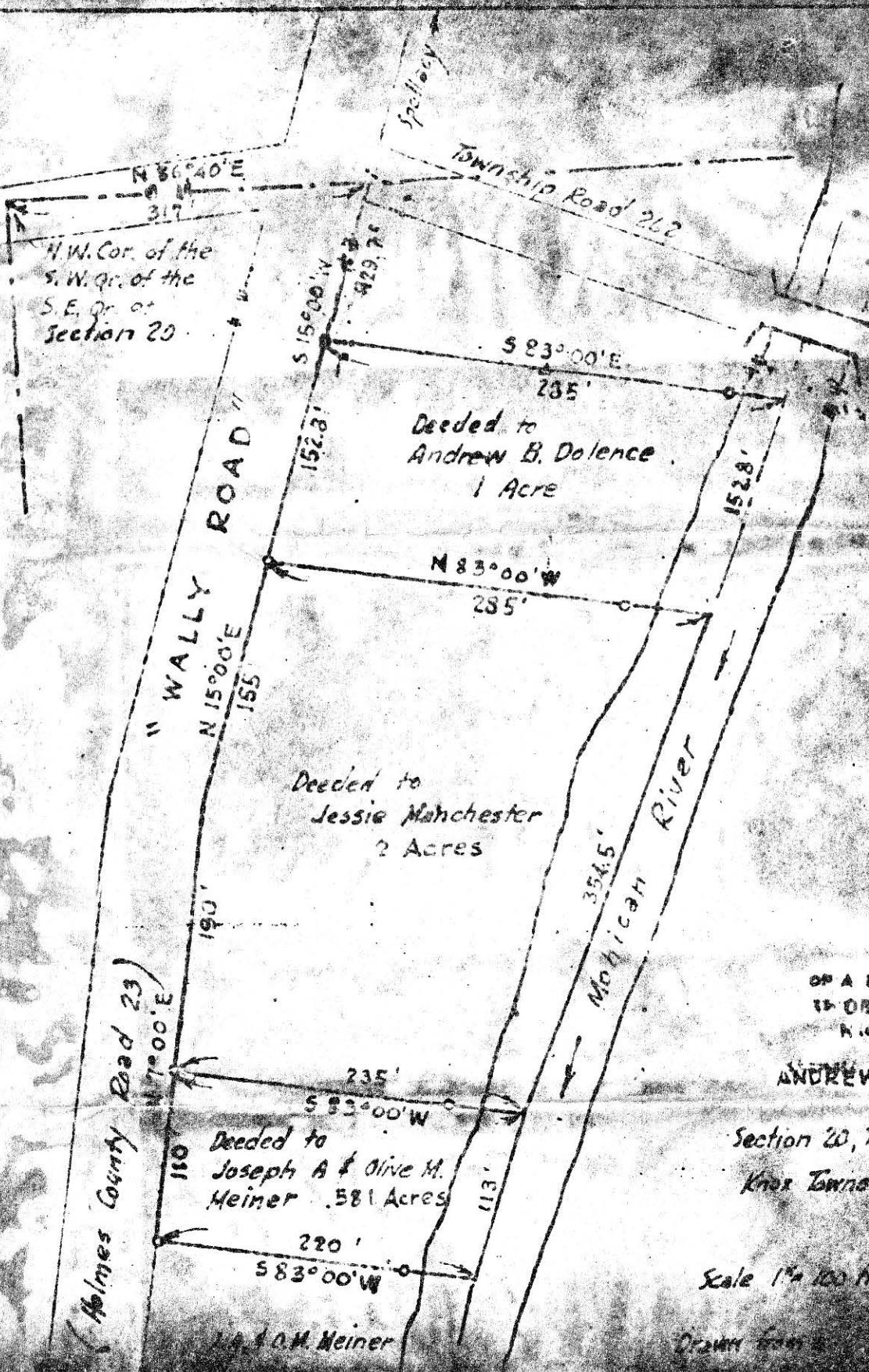


School House Property

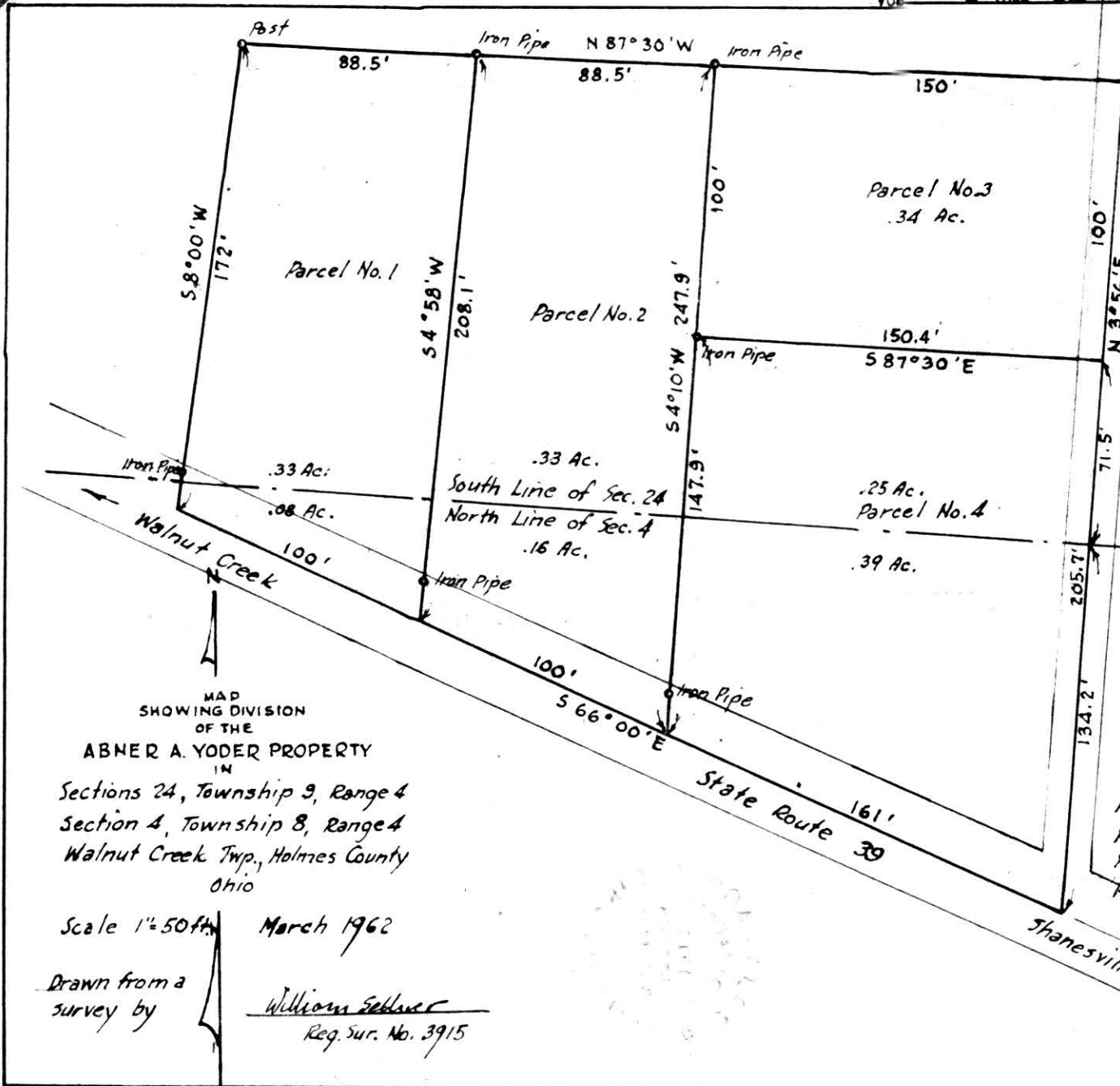


MAP
