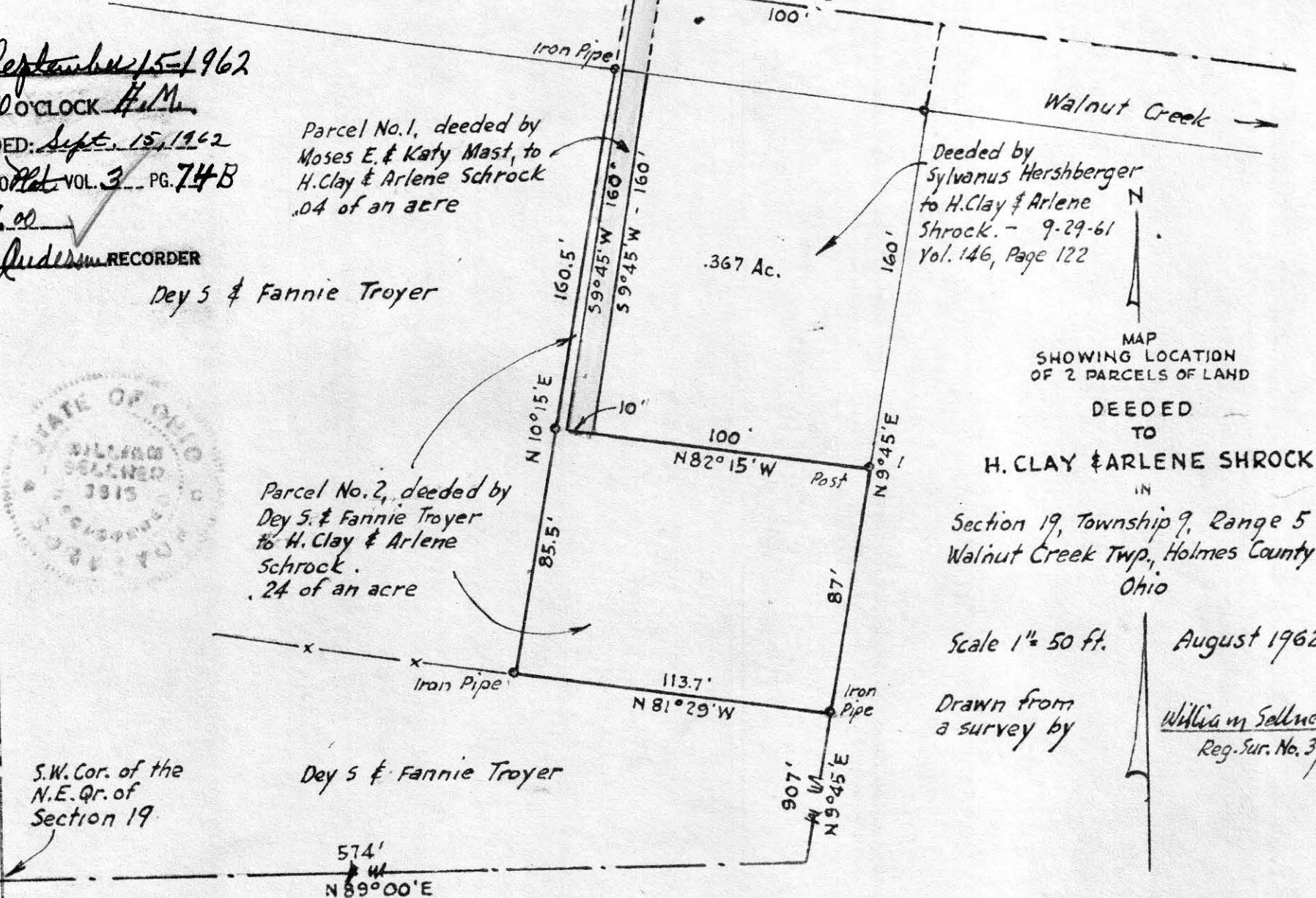

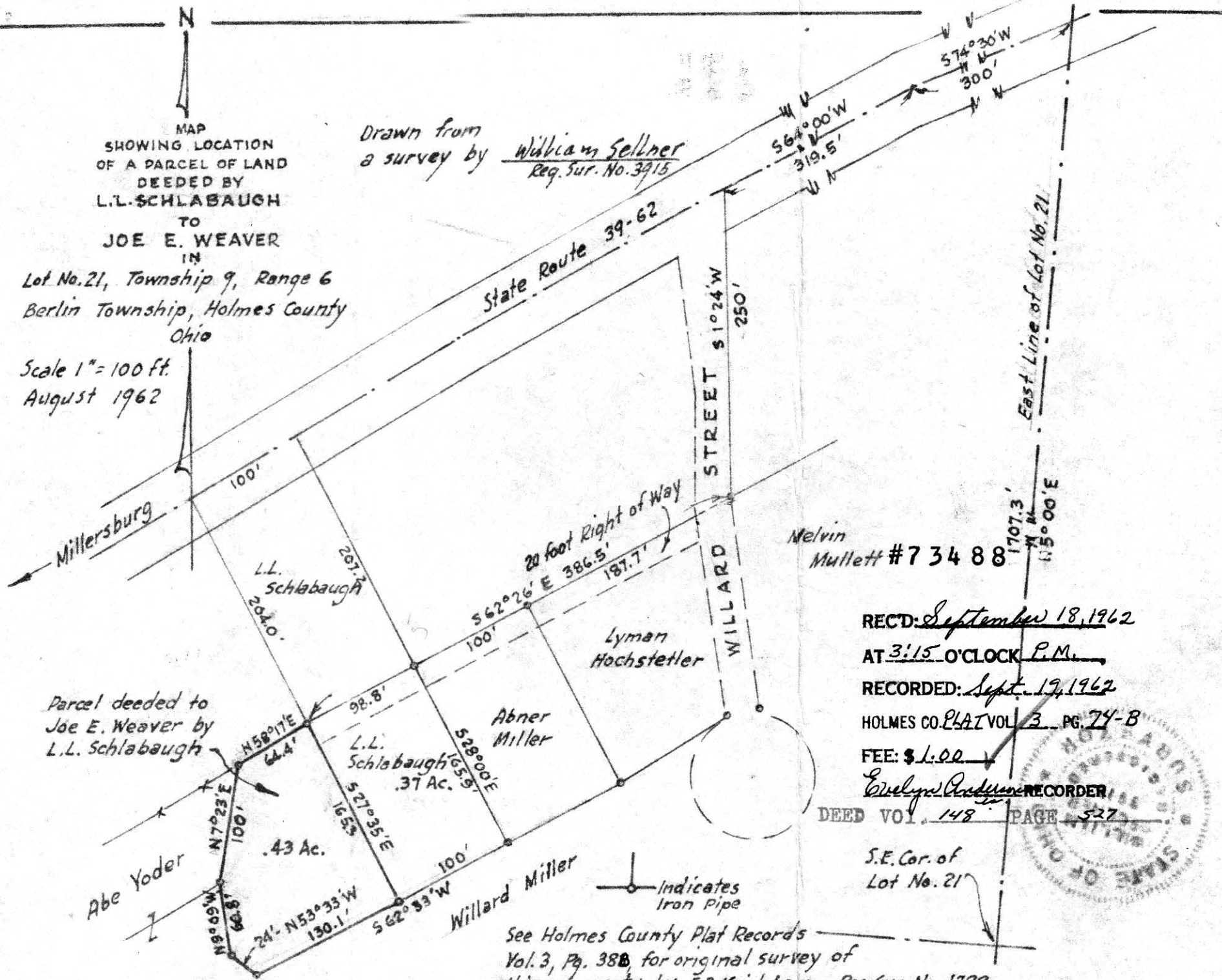


MAP

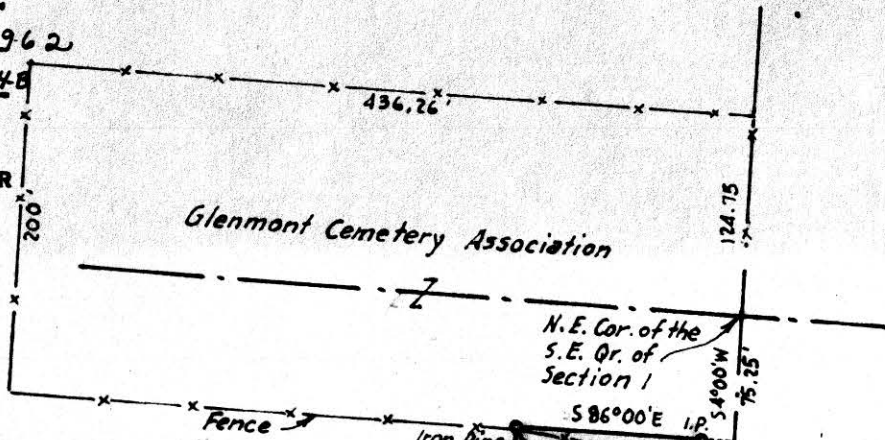

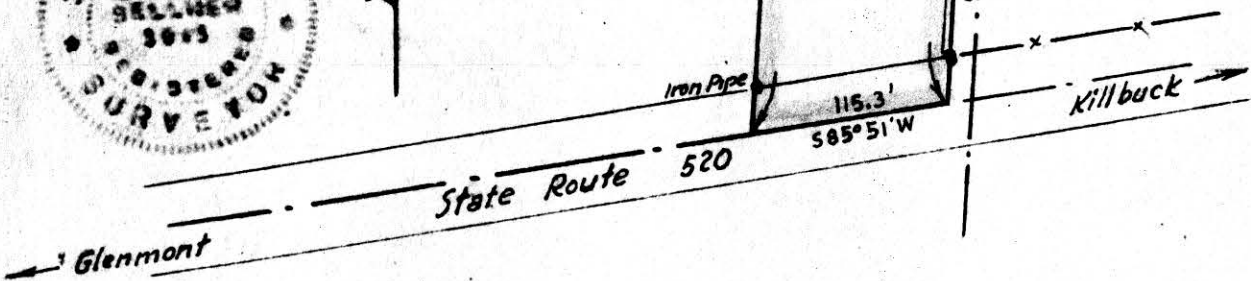

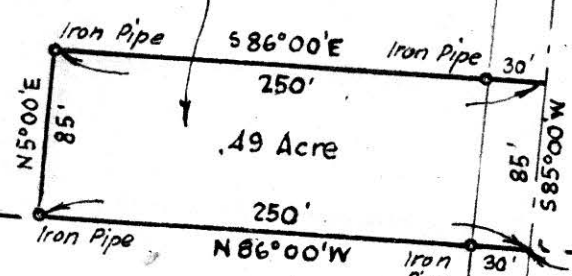
