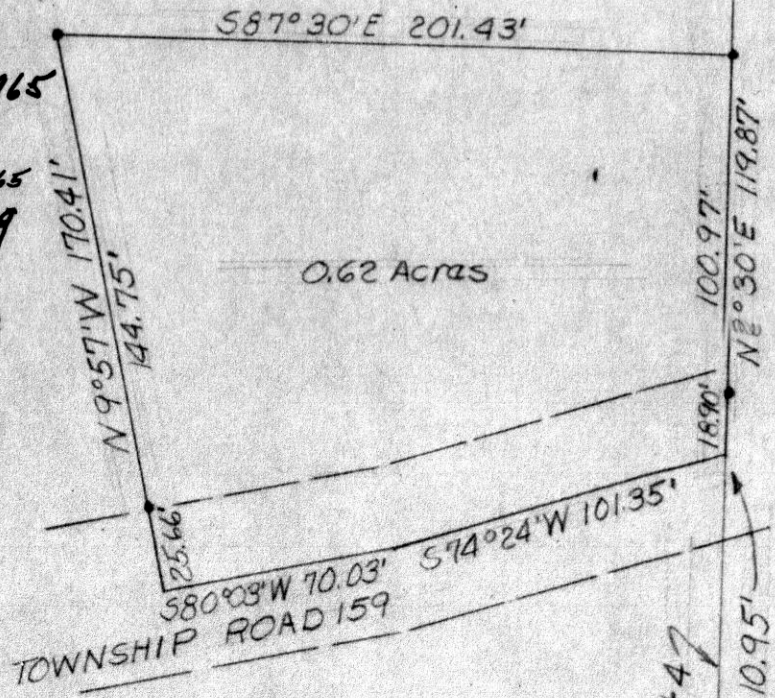

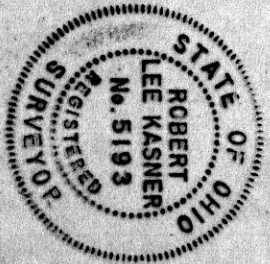


LANDS OF BEN E. & KATE WEAVER

Stone at Southeast Corner of Lot 4

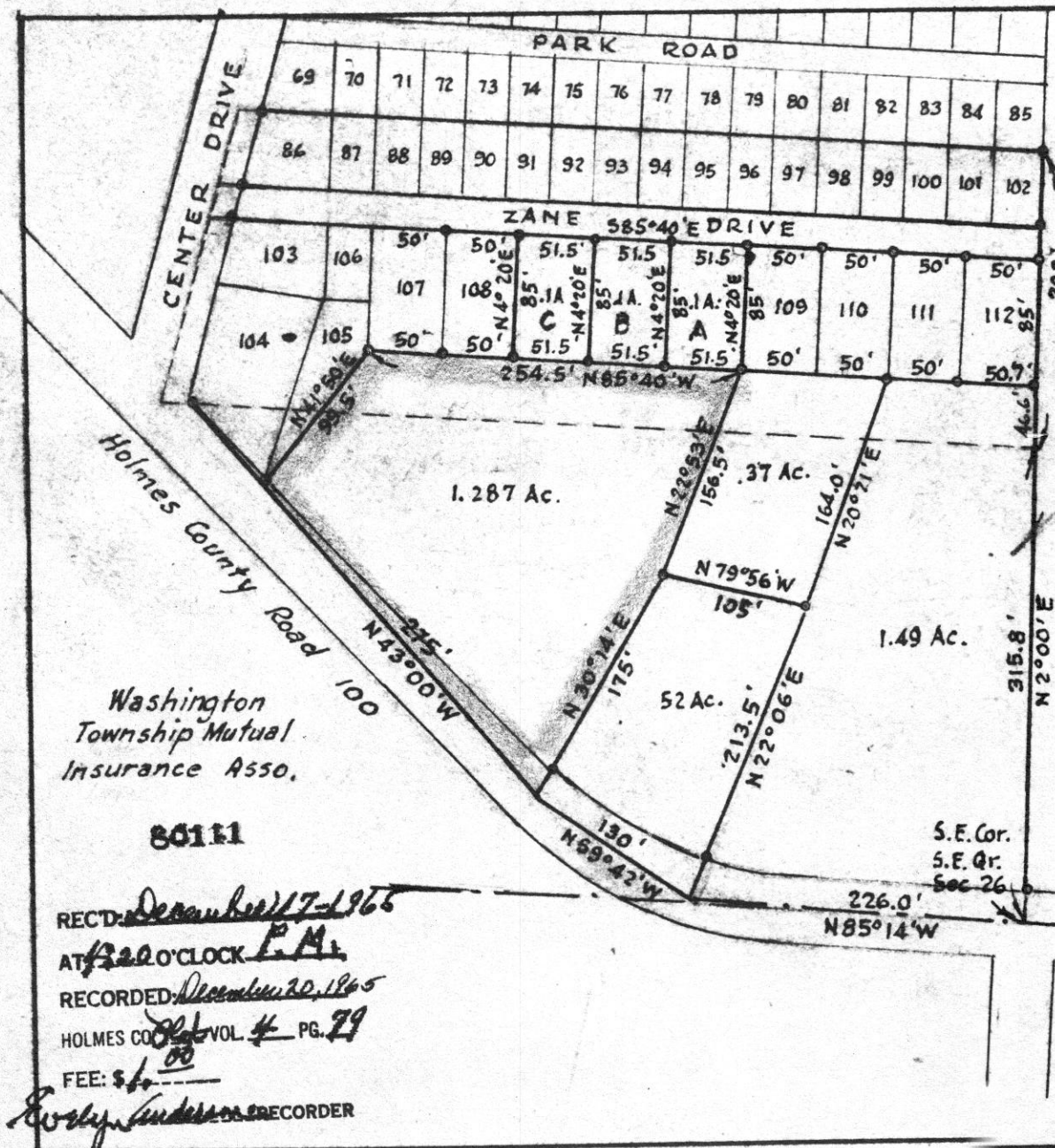

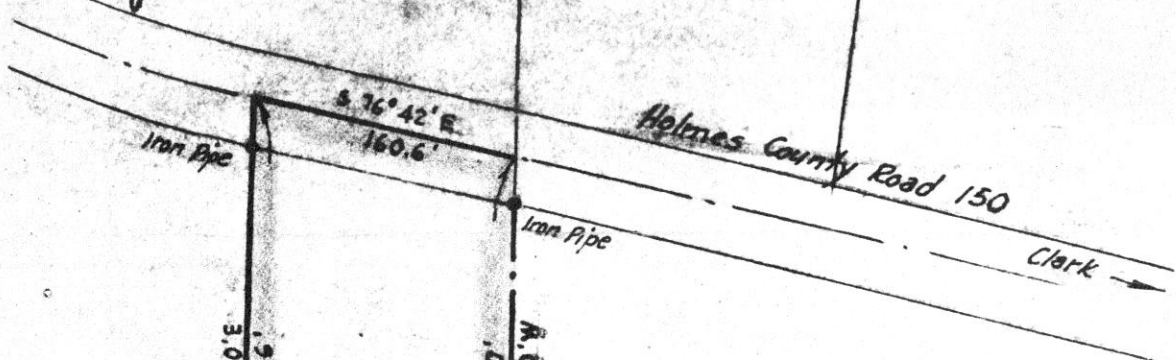
