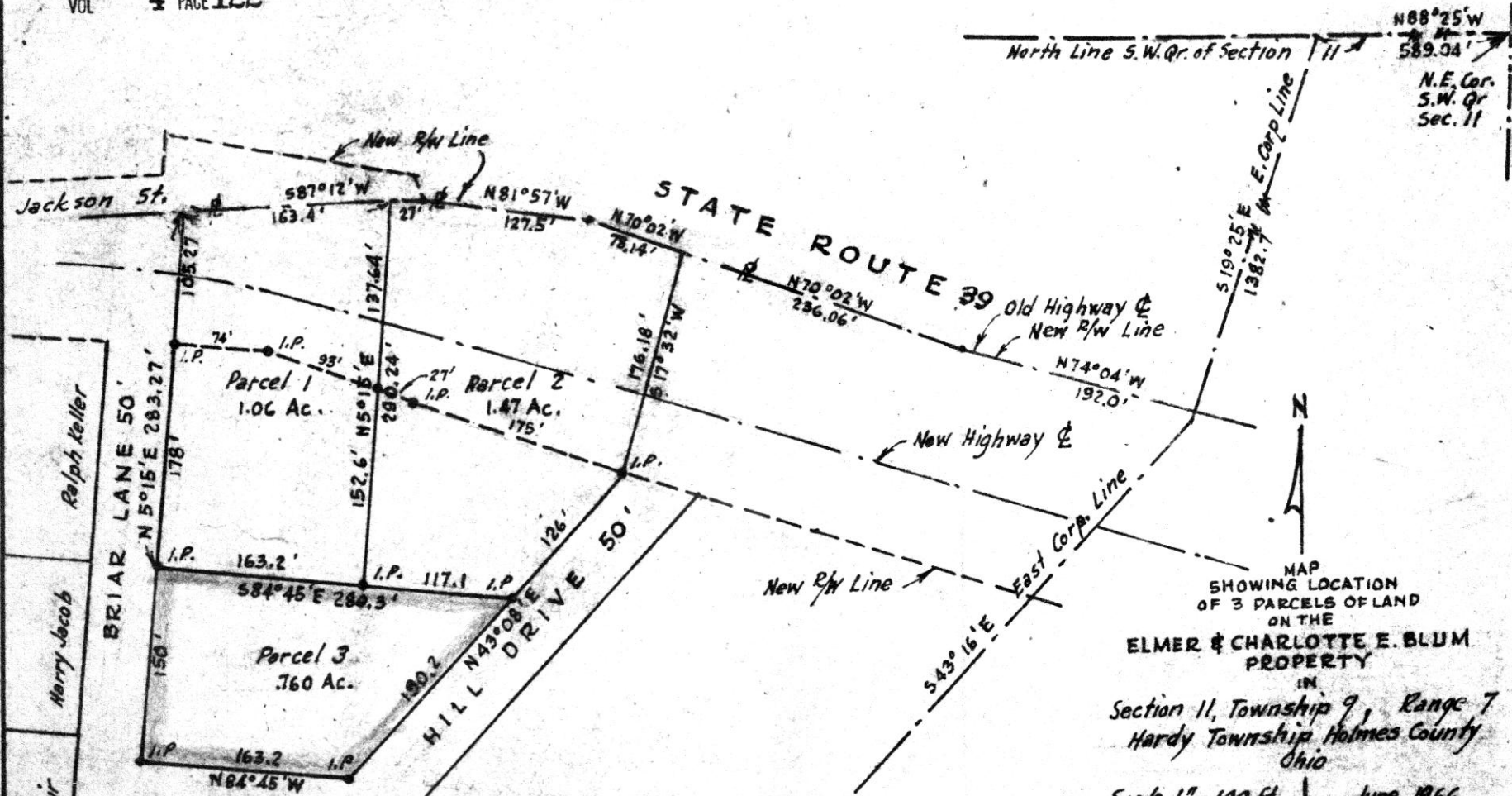

PROPERTY

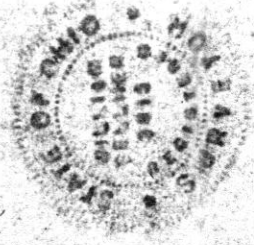
